

**ROCKFORD CITY COUNCIL PUBLIC HEARING
& REGULAR MEETING**

**AUGUST 14, 2018
7:30 P.M.**

1. The Rockford City Council met in regular session at City Hall on Tuesday, August 14, 2018. Mayor Johnson called the meeting to order at 7:30 P.M. Present were Council Members Johnson, Marth, Paulus, Stokes and with Arndt absent. Citizens present were Dennis Ginther, Andy Achenbach, Janette Lien, Larry & Sharon Hicok, Andy Smith with WHKS, Kevin Graves with WHKS, Alan Powell with Jendro, Kellan Heavican with KCHA and Public Works Director Randy Schweizer.

Motion Marth, sec. Stokes to approve the agenda as posted. Passed all ayes roll call vote.

2. Motion Marth, sec. Stokes to open Public Hearing at 7:31 P.M. for purposed Johnson Addition Lots 2, 3 & 4 as published. Passed all ayes roll call vote. Mayor asked for any written or oral objections or comments: there being none, Motion Marth, sec. Johnson to close Public Hearing at 7:32 P.M.
3. Motion Marth, sec. Johnson to approve Resolution #2018-12 approving the bid for Lot 2 from Andy Achenbach for \$7,374.00. Passed with the following roll call vote: Paulus, Stokes, Johnson and Marth. Absent: Arndt.
